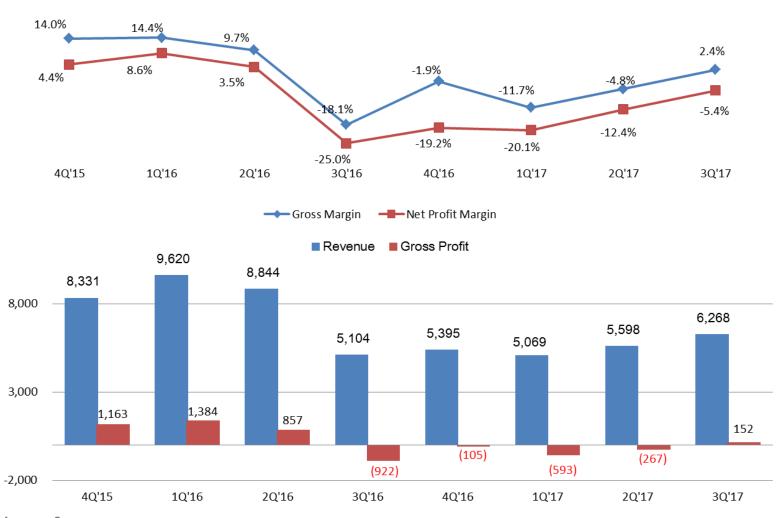

#### **Quarterly Revenue and Margin Trend**

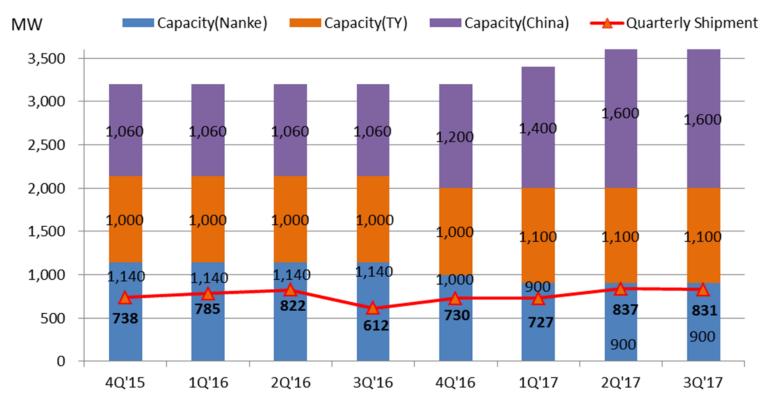






#### 3Q'17電池產能與出貨概況

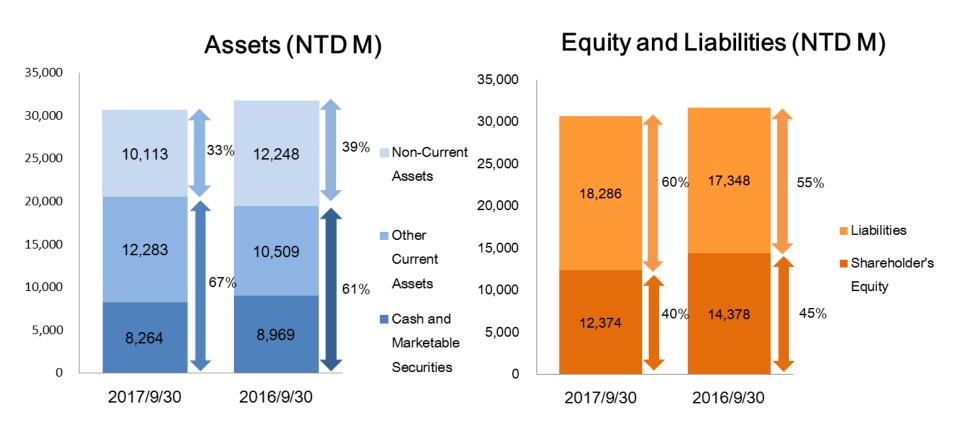
